BOARD/GENERAL MEETING

Announcements and Old Business

- Board Meeting was called to order by Megan at 6:06pm
- Account standings were read by Cheryl
 - o Corry Credit Union: \$4368.66
- Expenses since the last meeting were discussed, and included finalizing all year-end award purchases.
- Eric real the meeting minutes from the board/General meeting on September 8th, and they were accepted by Jesse, seconded by Cheryl.
- The next meeting will be on January 5, 2023, with the time TBD. This meeting will start with the board, then transition into a general meeting.
- Membership totals for the year remain at 39.

New Business

- Awards Banquet
 - The board determined the best date for the banquet would be January 28, 2023, due to showing conflicts with many of our members.
 - Possible locations were discussed and the board will collectively research and choose a location before the end of the year. The locations discussed are listed below:
 - Conneaut Lake Hotel Lower room
 - Riverside Brewing Company
 - American Legion in Mercer, PA
 - The Gathering (near Grove City)
 - Pricing will be determined based on the location chosen, and RSVP forms will be mailed as soon as possible. RSVP forms will have the ability to pay via paypal or cash/check.
 - The board decided to add a Chinese auction to the banquet, and anyone who brings a an item will receive a page of tickets.

- All prizes will be reviewed by Megan and Eric to check for accuracy within the coming weeks.
- 2023 Show Season
 - The board voted to finalize the dates of June 24-25 and July 29-30 at Lake Erie College. They have also determined they want to hold a 3rd weekend show on May 20-21 but have to wait on confirmation from LEC regarding availability.
 - If LEC is not available, the board decided to move forward with a single day show at Trinity with a Friday evening clinic in the warmup arena to recover lost costs of a second show day.
 - Megan will connect with LEC or Trinity to secure the 3rd weekend and update the board via the Facebook group chat.
 - Brandon and Jesse expressed concerns regarding the sound system at LEC, requesting that they find a solution to the sound not working in the barns prior to our shows.
 - New policies were discussed, and the board determined that a non-refundable stall deposit of \$50 for all shows will be part of the show season.
 - Alisha was also filled in on previous board decisions to decrease the jackpot percentage from 70% to 50% and increase all class fees by \$5 except leadline and short stirrup. These changes are due to the increase in venue costs.
 - O The board discussed the use of specialty classes and shootouts for the season and determined that they were an excellent way to draw in entries. The decision was made to also put a poll on Facebook to let the public choose what classes we host. The following were discussed:
 - Green Reiner Shootout
 - Rookie Shootout
 - Open Ranch Shootout
 - Ranch Trail Jackpot
 - Freestyle Jackpot
 - Judge and/or People's Choice buckles
 - Showbill changes
 - Alisha was informed on previous board decisions regarding class changes for the showbills. The following were determined:
 - Changing all class titles for Green Horse to be Novice Horse, so "Green" describes the rider.
 - Adding a short stirrup ranch class, ranch rail classes, and separating green ranch into green rider ranch and novice horse ranch
 - Paid positions
 - The board agreed that the paid positions for shows this year will be the judge, announcer, show secretary, and scribe.
 - Clinics
 - We discussed the use of a clinic in the fall to maintain exposure of the club in the off-months and to raise money.
 - Alisha shared her connection with a few clinician options and venues.
 - The board tabled the idea until the next meeting when they knew more about the show season dates and locations.
- Membership
 - Membership fees will remain the same as last year, with the exception of the early discount. The discount for submitting your membership early is being lowered to \$5.

O Work hours was discussed in detail, and it was determined that the amount of work hours required by all members to be eligible for year-end awards will be 3 hours each. These hours can be worked by another individual, parent, etc. but must be completed for each member before the end of the season. The possible positions for work hours were discussed, but not finalized. The list includes: office runner, gate person, garbage cleanup, show setup, show cleanup.

By-law changes

- O Brandon suggested we change the eligibility requirements for the next round of elections/nominations for the president position. The board decided that in order for someone to be eligible for nomination into the presidential position, they must have served on the board for at least one year prior to being nominated, along with all other eligibility requirements listed in the by-laws. This was 1st by Alisha, 2nd by Cheryl, with all in favor saying "I", creating a unanimous decision.
- Other by-law changes were discussed relating to the class changes and Megan will update those definitions and send to the board for a final review.
- Sponsors and Fundraising
 - The first sponsor of the year is Creative Imprint Systems, who donated 24 T-Shirts to the club due to a mistake when creating the year-end award shirts. The cost of the shirts was \$320; thus, they are a Gold sponsorship.
 - The board discussed other products they may have for order, such as hoodies and hats. Jesse suggested the board purchase hoodies to wear and display for ordering purposes. Alisha shared her "swag" ideas for adding them to the show bills of riders (making it seem less of an out-of-pocket purchase).
 - o A tack swap was suggested by Megan, with little discussion from the group.
 - Morgan shared what Slippery Rock Equestrian Team is currently doing on Facebook with gift card donations and random drawings. The board plans to look into it and determine if it would be something we can do.

Final Thoughts

Board meeting was adjourned by Megan at 7:41pm, seconded by Jesse and Morgan.

The board meeting ran over into the general meeting. Paula and Morgan were given a recap of the board meeting thus far, then participated in the remainder of the meeting discussions. Both meetings were adjourned together.
